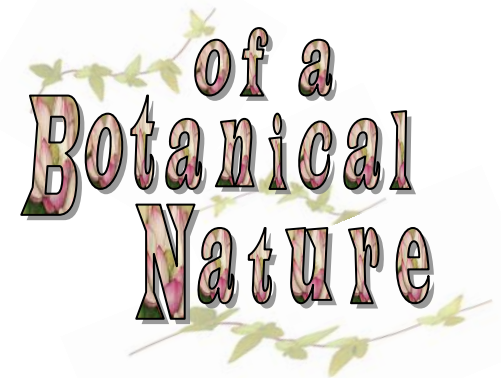

Of a Botanical Nature:

A call for original artwork that reflects the beauty and uniqueness of flora (realistic or representational style). Plants and all aspects of plant development such as seed pods, leaves, fruits, and flowers are appropriate. All media considered except photography and computer generated art.

About the juror:

Wendy Hollender is the coordinator for Botanical Art and Illustration at the New York Botanical Garden. She teaches students there as well as leading workshops in exotic locations such as Trinidad, and Hawaii. Through her work developing floral designs for clients such as Wedgwood China and Westpoint Stevens, she became intrigued with the complex beauty of plants.

This fascination inspired Wendy to earn a certificate of Botanical Art and Illustration, and become a full time Botanical Artist and Illustrator. Currently some of her clients include: the French beauty company Coty Inc., the Riverside Park Fund, the Morven Garden and Museum, the Nantucket Conservation Foundation and Caspari, Inc. Wendy is a graduate of the Rhode Island School of Design. She has exhibited her work extensively across the United States and England. Illustrations by Hollender have graced the pages of publications such as Country Living and Horticulture magazines and the Missouri Botanical Garden scientific journal Novon. Open to all artists age 18 & up. Work may not exceed 54 inches in width.

ENTRY DEADLINE:

Friday, March 19

ENTRY FEE:

\$40 for up to 3 entries

\$30 for STAC artist members **Artists may become STAC artist level members at time of entry.

LIABILITY / SALES:

Work will be insured for the duration of the exhibition. STAC will receive a 30% gallery commission on all work sold. All work must remain on display through May 28, 2010.

ACCEPTANCE NOTIFICATION:

Will be emailed by April 9

EXHIBITION RECEIVING:

Work must be received 4/22—4/25

PRIZE: One winning artist will be selected to participate in an annual Winner's Showcase

Entry by 300 ppi Jpegs on CD only.

Please size your images

Largest side 1600 pixels

CDs must be labeled with artist name.

Jpegs must be named with *artist last name, first name, title of work.*

Copy of completed, signed entry form

Completed entry form must be filled out and returned to STAC with your entry CD and entry fee (check payable to STAC) *If you have a problem with the word form, please download the pdf copy, complete the form by hand and submit with your entry cd. CD must be labeled with artist name. Please title your jpegs consistent with your entry form titles.

Please do not use all caps. Gallery label and lists will print from your entry form.**Caution: Entry will not be processed if instructions are not followed. CD's will only be returned if properly posted SASE is enclosed with your entry.

You must sign the entry form. Your signature confirms agreement to all terms of the prospectus, display & shipping requirements (posted at <http://www.stacarts.org/page/show/Exhibit+Forms+for+Download>) if your work is accepted.
